

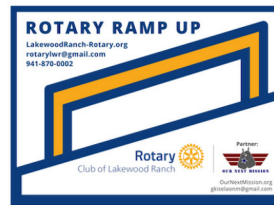

## Back to work to help renovate homes for veterans

Good news for the new Rotary year!

Pescara Lake in Bradenton has given Our Next Mission a home (pictured above) to renovate. We went through Lot 71 recently, and it is actually in fairly good shape for a 50-year-old mobile home. The carport and front porch need to be repaired or replaced; we ordered the material and it should be delivered in two to three weeks. One of our volunteers, Tom S., committed to taking the lead on this activity since he has previously replaced three other carports.

The air-conditioning unit was installed in 2018 and works well, making it easier to do our work inside. We need to replace a couple of windows. After we pull up the carpet, we hope to find the floor is pretty solid. The kitchen cabinets are old but serviceable. The bathroom looks good, but looks can be deceiving.

We will use the Suncoast Food & Wine Fest grant award from the Rotary Club of Lakewood Ranch to support this project. This week, beginning Aug. 5, we are ready to install the carport and porch on Unit 71. The metal was delivered onsite late last week. Simultaneously, we will have a team assisting the Venice High School JROTC on Aug. 6 to put the finishing touches on an Obstacle Course they have been building for the past couple of years. Rotarians **Terry Byce** and **Russ Sexton** will be part of both of these efforts. See the attached photos of Unit 71.

Please let me know via text/email (or in person at club meetings) if you can help out any workdays on Monday, Tuesday and Thursday from 7 to 11 a.m. (beat the heat!) beginning July 29. No experience needed, just a desire to help someone in need. Any time you contribute is appreciated. This unit will take approximately two to three months to complete. I will provide you with directions.

Also, see the photo at right of the ramp installation that was done a few weeks ago for our mobile home unit at Colony Cove in Ellenton. We moved a veteran and his wife into this unit over Memorial Day weekend. The ramp had to be hand-fabricated due to the unique conditions that we had.

# TUTORIAL: HOW TO APPROACH RESTAURANTS FOR WINE FEST

## 1) Preparation:

- a) First, select restaurants with which you already have a relationship before contacting others.
- b) Prepare a script and practice it well to sound spontaneous and informative.

## 2) Phone Call:

- a) Ask for the individual who makes decisions for the restaurant. Give the prospect reasons to believe that the Suncoast Food & Wine Fest will benefit their restaurant. Answer questions to the best of your ability. Get a firm date and time to meet.
- b) If the restaurant cannot participate, request a donation of gift cards.

## 3) Possible Obstructions:

When asked for an email describing the event, try to determine if it is for real or a stall. Continue to try to get a face-to-face meeting. If you believe the request to be valid, prepare a glowing description of the event followed by a phone call to determine interest.

- b) Watch for managerial changes. The new manager might not be inclined to participate, necessitating a new effort.

## 4) Meeting:

- a) Be on time, upbeat and warm. Ask individuals to talk about themselves. Once the ice is broken, open the Wine Fest pamphlet with it facing the manager. Show them the satisfied past participants and the many charities to which we donate. Describe how attendees enjoy the signature dish and how participating restaurants get exposure that may increase their clientele. If you cannot address questions, tell the client that you will get back to them. If you detect sufficient interest, now is the time to ask them to fill out the registration form. Review the completed form with the client before you leave.

## 5) Follow-Up:

- a) Call the manager a few times before the event to remind them of their decision. Let them know we appreciate their participation. Be prepared for questions.

### Why we need The Rotary Leadership Institute

The success or failure of a Rotary Club depends on the quality of club leadership. Often, poor club leadership is the primary cause of membership losses. Because of the annual turnover of club officers, Rotary needs a constant influx of knowledgeable Rotarians who have the leadership skills necessary to move a club forward. It is difficult to learn enough about the exciting world of Rotary with its more than 1.4 million members in more than 200 countries and geographical areas. Furthermore, leadership skills in a voluntary organization are often different from business leadership skills. RLI provides an opportunity for quality Rotary education that is usually not otherwise available.

### What is the philosophy of RLI?

RLI believes that having leadership skills does not alone assure good Rotary leadership. An effective Rotary leader must ALSO have Rotary knowledge, perspective about where Rotary has been, where it is now going and a vision of what Rotary can be.

### What is the "recommended curriculum"?

The curriculum is divided into three parts, generally taken on 3 separate days. RLI also recommends a program of graduate seminars for those who have completed the three basic Parts. Since the founding of RLI, the curriculum has been continually reviewed, updated and revised as the result of experience and the evaluations of the attendees.

### What are the teaching methods?

The Institute believes in course sessions with as much discussion/participation as possible. Course methods include discussion groups, role-playing, problem solving workshops and creating projects. Everyone participates during one of the Institute's sessions. Course materials including session outlines, the daily program, faculty listings and resource materials are provided to all participants.

### Who are the faculty?

Faculty members are carefully selected for their teaching abilities. Many are present and past district governors, presidents and those with experience in special areas. Each new faculty member must attend a full day training program and various periodic reorientation programs. The results of course evaluations help to improve the course content and instruction.

### Who should attend RLI courses?

Although any Rotarian may attend RLI courses, RLI recommends that Rotary Clubs encourage Rotarians who have the potential for future club leadership, not necessarily as club presidents, to attend. The ideal candidate is early in their Rotary career, has a strong interest, and is prepared to be exposed to the larger world of Rotary outside of the club. Clubs typically pay the fees for their members attending the courses.

### What are the costs?

Each course is currently charged at \$100, and includes tea or coffee, lunch, tuition and all course materials.

### What is an RLI division?

For administrative purposes, RLI creates "divisions" that may consist of one or more Rotary districts, countries, zones, etc. Each division works with RLI to arrange course schedules, set policies, and handle finances. Each division pays modest dues to RLI. Divisions are formed by written agreements signed by district governors and RLI officers. RLI has divisions/districts in every Continent of the world except Antarctica.

### Should our club participate?

This is an outstanding opportunity for each club to improve the Rotary knowledge of its key people, who will also be exposed to new ideas while creating relationships with members of other clubs. The exchange of ideas alone makes the courses worthwhile, and membership retention is improved.
