## Last Week's Highlights

- Sandra Langford, County Treasurer was our speaker. See her picture below flanked by Pres. Susan Brack and sponsor Charles Wright. Sandra has worked in various jobs for the county for 43 years. She discussed the Mecklenburg County tax bureau process and status in handling funding our county services. They operate on a fiscal tax year of July 1 to June 30 with 2 billing periods of June and December. There were 66,000 properties and 59,000 personal properties taxed last year. 29,000 were not paid on time so labeled past due. Of those, 2200 resulted in a debt warrant, 512 were imposed with wage garnishment, 2495 resulted in car registrations removed. 156 payments had bad checks. 104 properties were delinquent for 3 years and were listed for tax sale. Of those, 37 were sold due to continued lack of payment and fees. She emphasized her small staff is available to help those with problems paying with advice, monthly payment plans etc. They take great pains to work with individuals to help them meet their obligations without losing their homes or vehicles.
