Last Week's Program:

Susan Suhanovsky introduced Felicia Ortner, a volunteer at The Humane Organization Representing Suffering Equines (H.O.R.S.E.) of Connecticut Inc.

Felicia is involved with small fundraising efforts for the farm and explains that HORSE is a non-profit, 501(c)3 organization dedicated to the rescue and rehabilitation of abused and neglected horses. Over the past 42 years, H.O.R.S.E. has saved more than 750 lives. In addition to direct intervention, H.O.R.S.E. also maintains an ongoing commitment to educating the public regarding horse care.

She's obviously passionate about the animals and discussed at length with us the mission of H.O.R.S.E and via PowerPoint explained the organization. It was organized in 1981 and is governed by a seven member board of directors. It's run completely by over fifty volunteers with no permanent paid staff.

All horses usually have a dry paddocks where they are feed and groomed and kept for the night with most often two to three horses in a paddock. If needed, there is room in the paddocks to separate the horses for particular times for whatever reason. They can provide some horses special food, feed and special hay, and necessary medication if and when required.

Some facts:

- There are over 200,000 unwanted horses each year.
- 1 in 4 abuse cases are horses one of the most commonly abused animals
- It has been found that there's a correlation between domestic abuse and animal abuse
- There are about 1,500 horse rescues in the U.S. ahomeforeveryhorse.com
- There are about 20 horse rescue organization presently in Connecticut
- 70% of horse rescues are at or over capacity.
- Usually, unless rescued, abused, mistreated, abandoned, or horses that for little or no reason will be destroyed.
- FBI will be adding cruelty to animals to the annual Uniform Crime Report.
- Only about 33% of communities report abuse.
- HORSE investigates all cruelty complaints (which are kept strictly confidential). If a problem exists, cooperation is first sought from the owner. Prosecution is pursued only when there is no

other recourse. Horses placed in our custody are provided with immediate veterinary and farrier care before adoptive homes that meet policy standards are sought.

It was a very informative and eye-opening presentation and we thank Felecia for her time with us and Susan Suhanvosky for bringing her to us!

For Your Edification:

In 1970, shortly after being elected Attorney General of Alabama, 29-year-old Bill Baxley reopened the case of the 16th Street Church bombing, a racially motivated act of terrorism that resulted in the deaths of four African-American girls¹ in 1963 and a fruitless investigation, which marked a turning point in the Civil Rights Movement. Baxley's unwavering commitment to the

case attracted much hostility, particularly from local Klansmen, and in 1976 he received a threatening letter of protest from white supremacist Edward R. Fields—founder of the National States' Rights Party and "Grand Dragon" of the New Order Knights of the Ku Klux Klan—in which he was accused of reopening the case for tactical reasons. Baxley's magnificent letter of reply, **seen below**, was both succinct and unambiguous.

The next year, a member of the United Klans of America named Robert Chambliss was found guilty of the 16th Street Church murders. He remained in prison until his death in 1985. Two decades later, the two remaining culprits in the case (one of the Klansmen had since died) were also prosecuted.

The girls were Addie Mae Collins (14), Cynthia Wesley (14), Carole Robertson (14), and Carol Denise McNair (11). Wikipedia has thorough accounting of the tragedy:
